CMHI 2018 CONVENTION HIGHLIGHTS

Ray Gritton Honored with CMHI's 2017 Jack E. Wells Memorial Award

Over 170 industry members attended CMHI's Annual Jack E. Wells Memorial Awards Banquet on March 22nd at the Omni Rancho Las Palmas Resort and Spa in Rancho Mirage.



Ray began his career in the manufactured housing industry in March of 1974, when he opened Instant Housing of California with four locations in Northern California. In May of 1996, he sold his business to Oakwood Homes, Inc. in Greensboro, N.C. and became Vice President of the Western United States.

In 1998, Ray became Executive Vice President, Retail Sales in the U.S. for Oakwood Homes, Inc. In June of 2001, Ray opened R.W.G. Enterprises, Inc. in Salida, California. Also known as Homes Direct, there are thirteen sales locations in five western states; four in California, two in Oregon, three in New Mexico, three in Arizona and one location in Washington.

In 2017, Homes Direct closed sales on 659 homes with over \$50,000,000 in wholesale sales transactions and \$75,000,000 in retail sales. R.W.G. Enterprises – Homes Direct, has been the largest independent manufactured home retailer in the Western United States for the past five years. Ray's dealership is also the second largest independent retailer in the entire United States.

The Jack E. Wells Memorial Award is CMHI's most prestigious award and signifies our respect and gratitude for Ray's leadership and service as a role model to be emulated.

Jim Joffe

Jim, along with partner, Bill Hanks formed J & H Asset Property Mgt., Inc. in 1986. As President, Jim directs the mobile home and RV park division of J & H, which manages over 120 communities throughout California, Arizona

and Nevada. Jim is a licensed manufactured home dealer and heads up Home Quest.

Jim has served on the Board of Directors for WMA and served as its President in 2009. In 2010, Jim was named the Busch, Carr & McAdoo Award recipient, WMA's most prestigious award.

Jim's son, Shane Joffe's presentation of CMHI's Lifetime Achievement Award was a moving testament to his father's contributions and success as a mentor.

Barry Cole

Barry began his career in manufactured housing in 1972 selling mobile homes at Foremost Motors in Compton, California. He then entered manufactured housing factory sales in 1976, elevating to General Sales Manager at Lancer Homes and Westway Homes. In 1986, he started his own manufactured housing retail operation, Red Label Housing in Orange, California and eventually transferred his manufactured housing sales license to Mobile Community Management Company in 1992. In 1999, he opened what is now Manufactured Housing Insurance Services.

The RV/MH Heritage Foundation inducted Barry into their Hall of Fame Class of 2014. Barry has also received the President's Award, Chairman's Award and the Jack E. Wells Memorial Award, plus the Lifetime Achievement Award from California Mobilehome Parkowners Alliance, CMPA.



Barry is currently serving on CMHI's Board of Directors and has continuously served as an Officer. 

Jess Maxcy President, CMHI

With the close of 2017, I found myself in a wonderful position...I was wrong? My forecast for a 5.9% increase in new manufactured home shipments for last year was too conservative. Our actual shipment of 3,681 homes exceeded my forecast by 11.4%.

- VIEWPOINT CONT'D -

California's continuing and seemingly ever-increasing need for affordable housing provides opportunity for continued growth in manufactured housing market share.

Constraints/Opportunities

California needs to produce at least 200,000 new dwelling units per year to begin to ease the shortfall of available housing units and stem the seemingly ever-increasing rise in home prices. Unfortunately, the production of new units hasn't reached even half that level for the past nine years.

At the close of 2016, the median California household income was \$67,739. At the close of 2017, California's median home price was \$550,990, requiring a minimum qualifying income of \$111,260 (Only 29% of households qualify).

During the same period, the largest decline in inventory, and consequently sales, were for homes priced at \$299,000 or less. The decline in sales did not occur because there isn't a market for those homes. It occurred because the inventory of for sale site-built homes in that bracket is extremely low.

As of December 2017, the inventory of for sale homes in the \$0 - \$199,000 bracket declined 32.9% and those in the \$200,000 - \$299,000 bracket declined 14.8%.**

Clearly, the demand for high value housing is strong. The degree to which manufactured housing becomes a growing source in fulfilling this need remains to be seen.

Site availability is a very important determinant in increasing manufactured home sales and the industry's market is virtually bifurcated: homes sold primarily as personal property in manufactured home communities and homes sited outside MHCs as real property, thus creating a two-pronged approach to expand the market for manufactured housing.

Though it is possible to increase the pullout/full rate in existing MHCs to match the industry's current production capacity, in my opinion, it is not probable in the near term. Nor is it likely new MHCs will be developed or a significant number of sites will be added to existing California MHCs.

While California's manufactured housing industry must do everything necessary to support its core business (sales in MHCs), it is doubtful that a significant increase in market share will come solely from replacement homes in established MHCs.

- VIEWPOINT CONT'D -

Therefore, it is important to recognize and take advantage of the opportunities for siting manufactured homes outside MHCs. To do so, manufacturers, retailers and lenders must work together to strengthen this segment of our retail distribution.

For 2018, CMHI's focus is on sponsoring legislation to:

- Provide funding for programs to replace aged homes in MHCs;
- Ease the process and reduce the costs to add lots to existing MHCs;
- Ease the process and reduce the costs to use manufactured housing as accessory dwelling units;
- Provide funding for the purchase of manufactured homes for farm labor housing.

Working together we can make 2018 a very good year!

If you purchased a mobilehome, but did not receive an official Certificate of Title from the California Department of Housing and Community Development (HCD), you may not legally own your home.

Have fees and back taxes prevented you from registering your mobilehome?

Effective January 1, 2017 through December 31, 2019, owners of manufactured homes and mobilehomes who are NOT currently the registered owners may be eligible to obtain waivers from certain fees and back taxes and apply to register their homes with HCD.

VETERAN'S AND AFFORDABLE HOUSING BOND ACT By Jess Maxcy

This November you will have an opportunity to support our nation's veterans, affordable housing and our industry by casting a vote on the Bond Act. Here is why you should vote

California is in desperate need of effective programs to resolve our housing crisis. The California Legislature recognizes manufactured housing as a viable and cost-effective resource that can contribute to the resolution of the housing crisis.

If passed in November, the Bond Act will authorize the issuance of \$4 billion in bonds to finance various housing programs. Among them are:

- \$300 million for farm worker housing which includes "the acquisition of manufactured housing".
- \$300 million in the "self-help housing fund" for among other purposes, direct forgivable loans for the acquisition of housing including manufactured homes.
- \$30 million of the "self-help housing fund" will be specifically dedicated to "provide grants and forgivable loans to assist in the rehabilitation, or replacement, or both, of existing mobile homes located in a mobile home or manufactured home community".

CMHI ANNOUNCES HOME EXHIBIT PROGRAM

Rather than "build it and they will come", how about "show them and they will buy"?

For manufactured housing, a key to growing sales is a well displayed home that attracts home shoppers who have not previously considered manufactured homes as a desirable solution to homeownership.

Qualified CMHI member retailers wishing to exhibit a home in local fairs, home and garden shows or other appropriate venues, CMHI has a program to support your efforts.

CMHI will issue up to 6 grants to qualified participants, to partially reimburse expenses incurred, for the display of a home in a **pre-approved** local venue.

SKYLINE AND CHAMPION HOME BUILDERS TO MERGE

Skyline Corp. (SKY) and Champion Enterprises Holdings, LLC, the parent company of Champion Home Builders, Inc., said that they reached a definitive agreement for the two companies to combine their operations.

As per the terms of the agreement, Champion will contribute 100% of the shares of its operating subsidiaries, Champion Home Builders, Inc. and CHB International B.V., to Skyline. In exchange, Skyline is currently expected to issue about 47.8 million shares to Champion, representing 84.5% of the common stock of the combined company on a fully-diluted basis. Prior to closing, Skyline expects to declare a dividend to its existing shareholders of its excess net cash available for distribution under the agreement after certain transactional expenses.

The combined company will be known as Skyline Champion Corporation and trade on the NYSE American under the ticker symbol "SKY". The Board of Directors will comprise eleven members, nine of which will be directors designated by Champion and two of which will be designated by Skyline.

Upon closing of the transaction, Champion Chief Executive Officer, Keith Anderson, will serve as Chief Executive Officer of Skyline Champion Corporation. Additionally, Laurie Hough, Champion Chief Financial Officer, will serve as Chief Financial Officer of the combined company.

Skyline anticipates nominating John Firth, current Chairman of the Board of Skyline, and Rich Florea, current Chief Executive Officer of Skyline, as Directors of the combined company and Art Decio, an original founder of Skyline and a member of the Board of Directors since 1959, as a senior advisor to the combined company's Board of Directors. Skyline Champion Corporation's principal offices will remain in Elkhart, Indiana with additional executive offices in Troy, Michigan.

Art Decio, Skyline's largest shareholder, has agreed to vote in favor of and fully support the transaction.

The transaction, which is expected to be completed in the first half of 2018, is subject to the receipt of regulatory approvals and other customary closing conditions as well as the approval of Skyline shareholders.

RADCO NEWS

RADCO was the first third party agency in California to plan review and inspect modular projects that utilize repurposed shipping containers. The project was the Waldorf School of Orange County located in Costa Mesa. Since then, the trend of using shipping containers has attracted many contractors and builders across the country. Currently, there are no regulating rules or guidance in the ICC model codes for this type of structure.

RADCO has been developing criteria and methods to review shipping container buildings. Each state modular program has a unique approach to addressing shipping container buildings. Some states have accepted RADCO's plan review methodology. Others have kept these containers out of their jurisdiction entirely. The Modular Building Institute (MBI) recently created a task force with the goal of establishing baseline criteria for evaluating shipping container building. This task force will also work with ICC on acknowledging this type of construction and adopting codes to legitimize it. This effort will in turn enable States to adopt such codes into their modular building programs.

RADCO's Vice President of Plan Review Services, Hala Jawad, AIA and Plan Review Engineer Mohsen Anis, P.E. are currently serving on the MBI/ICC task force. They have been working together to develop RADCO's criteria for reviewing the shipping container buildings. You can find the white paper, the product of that task force <u>here</u>.

RADCO has also been invited to participate in the committee that ICC has formed to develop the code for use of repurposed shipping containers in modular projects.






#### 2018 MANUFACTURED HOME PRODUCTION/SHIPMENTS YTD (MARCH)




#### 2018 REGISTRATIONS (NEW SALES) BY COUNTY OF HOMEOWNER YTD (MARCH)




